

# **Rules of Chiseikan Dojo**

## **Chapter I General Membership Provisions**

### **Article 1 (eligibility for admission)**

1. Those who wish to become a member of the Chiseikan Dojo shall respect the policy of the Chiseikan Dojo, apply for the membership in accordance with the rules and regulations, obtain the approval of the Chiseikan Dojo, and pay the prescribed membership fee and monthly membership fee to the Chiseikan Dojo to obtain membership status.

2. Members such as gangsters, extreme right or extreme left, and others who are deemed inappropriate as members of the Chiseikan Dojo cannot join.

### **Article 2 (membership requirements)**

Members of the Chiseikan Dojo shall meet the following requirements.

1. Members must observe the rules of Chiseikan Dojo.
2. Members are authorized by Chiseikan Dojo.
3. The members are healthy.

### **Article 3 (members)**

All students who have completed the registration procedure will be members.

As for the age of each member, it must be above elementary school age.

### **Article 4 (membership obligation)**

Members must pay the prescribed membership fees.

Members are obliged to pay the unpaid amount regardless of whether they participate in lessons or not, and during the period of delinquency, they lose their qualification to participate in lessons or examinations.

### **Article 5 (admission fee) 10,000 yen**

Membership fees must be paid at the time of enrollment. Exceptions are made during special campaigns.

### **Article 6 (monthly membership fee)**

The membership fee for children is 8,000 yen (practice is held once per week).

Membership fees for general members are (once a week) 7,000 yen, (twice a week) 10,000 yen, and (3 or more times a week) 13,000 yen.

The monthly membership fee will be withdrawn on the 26th of each month.

### **Article 7 (management system cost)**

All members have to pay 1,000 yen a month for the management system. The management system fee will be debited together with the monthly fee.

### **Article 8 (Submission of matters to be changed)**

Members must promptly report any changes to their address, contact information, or other information on the application form to Chiseikan Dojo.

### **Article 9 (Pausing Membership )**

1. Members who wish to take more than a month off from lessons and waive membership fees must submit a notice of their absence by the 20th of the previous month. If the notice of absence is not submitted by the 20th, the obligation to pay the membership fee for the next month will continue.

The following situations are deemed appropriate for pausing membership:

2. When it is judged that the person in question cannot use Chiseikan Dojo due to overseas travel, transfer, etc.
3. If the person is unable to use the Chiseikan Dojo due to pregnancy, illness, injury, injury, etc., and does not intend to withdraw from Chiseikan Dojo
4. In other cases where the request for absence is deemed to be based on a justifiable reason

### **Article 10 (withdrawal)**

1. If you withdraw from Chiseikan Dojo, you must fill out the designated form and bring the notification of withdrawal to the dojo **by the 20th of the previous month**. For submission of withdrawal, **we do not accept calls, faxes, LINE, emails, etc.** If you have a situation that you can't come by any means, please consult with the main teacher. If you do not submit a notification **by the 20th of the previous month**, you will continue to be obliged to pay the membership fee in the month after your withdrawal. In addition, if there are unpaid fees such as membership fees, you have to pay them in full.
2. The membership fee for the month of withdrawal must be paid in full even in the middle of the month.

### **Article 11 (expulsion)**

If a member falls under any of the following items, the membership will be suspended or expelled.

1. In the event of violation of the terms and conditions of Chiseikan Dojo and other rules and regulations, or the terms and conditions of use
2. In the event that Chiseikan Dojo is slandered or seriously damaged
3. When the payment of various expenses to the Chiseikan Dojo is delinquent for more than two months and the request for payment to the Chiseikan Dojo is not accepted. Please note that even in

the instance of expulsion, expenses incurred during the period of membership must be paid in full.

4. When an act contrary to public order or morals has been committed

5. In any other case where Chiseikan Dojo is deemed to be unsuitable for membership

#### **Article 12 (loss of qualification)**

If a member falls under any of the following items, he/she shall lose his/her qualification.

1. withdrawal

2. expulsion

3. death

4. The closure of Chiseikan Dojo

#### **Article 13 (transfer of membership)**

Membership shall not be transferable.

#### **Article 14 (Observance of rules and regulations)**

Members of the Chiseikan Dojo shall comply with this contract and the rules, and shall follow the instructions of the instructors and instructors of the Chiseikan Dojo when using the facilities of the Chiseikan Dojo.

In the unlikely event that you are injured, or during your commute to or from the Dojo, the member is solely responsible for any injury, accident, or damage to the equipment, and the Chiseikan Dojo is not responsible at all.

#### **Article 15 (restrictions of use)**

The use of all or part of the facilities of the Chiseikan Dojo may be restricted for a certain period of time if it is deemed necessary for events or other reasons.

#### **Article 16 (Holidays or Practice Breaks)**

1. On holidays from practice, members of Chiseikan Dojo will be informed previously in the published schedule. In addition, in the event of an emergency such as a natural disaster in the Chiseikan Dojo, or in the event of an emergency in which there is a risk of the spread of illness, or when repairing or renovating facilities, all or part of the facilities in the Chiseikan Dojo may be closed for a certain period of time.

2. The Chiseikan Dojo may be closed during an event or special practice session.

#### **Article 17 (closure of Chiseikan Dojo)**

In the event of unavoidable circumstances, the Chiseikan Dojo may be closed after a certain period of notice, and Members shall not raise any objections or make any kind of request with respect thereto.

### **Article 18 (responsibility)**

1. The Chiseikan Dojo shall not be liable for any personal or physical accidents that occur to the person or a third party when using the facilities of the Chiseikan Dojo.
2. If a Member causes damage to the Chiseikan Dojo or a third party when using the facilities of the Chiseikan Dojo, the Member shall promptly assume the responsibility for compensation.
3. The Chiseikan Dojo shall bear no responsibility to its members or users for any theft, injury or other accident that may occur within its facilities.
4. There is no bicycle parking or parking lot. In principle, please walk or park at a coin parking lot near the dojo. The Chiseikan Dojo is not responsible for any unauthorized parking at the nearby coin laundry, bicycle parking, or parking lot.

### **Article 19 (prohibited acts)**

The following acts are prohibited not only in the Chiseikan Dojo but in the entire Justin Onmae Building.

1. Smoking, eating and drinking outside the designated areas
2. practice under the influence of alcohol
3. Gambling, soliciting, selling, and similar activities that cause trouble for other members
4. Unauthorized questionnaires, requests for cooperation, etc.
5. Bringing Dangerous Goods and Pets
6. Other acts that do not fit the purpose of the facility of the Chiseikan Dojo

### **Article 20 (Rules)**

Specific matters necessary for the operation of the Chiseikan Dojo shall be separately distributed and may be changed as necessary.

### **Article 21 (personal information)**

Member's personal information (i.e. photos) may be used for events in the Chiseikan Dojo and other announcements.

### **Article 22 (Personal Grooming)**

- Members are requested to remove lipstick or colored lip gloss during practice. (If lipstick gets onto an opponent's uniform, it is difficult to remove.)
- Members are requested to keep their nails clean and short (these may hurt their opponents or peel off if they get caught in their partner's uniform).
- No jewelry or other adornments (watches, earrings, wedding rings, anklets, misangas, etc.) are allowed. If rings or bracelets are impossible to remove for practice, they must be covered by something such as surgical tape or a wrist band so there is no chance of them causing harm

to a practice partner.

**supplementary provision**

This Code shall come into effect on April 1, 2021.
